

5	DESIGN BUILD AND TURNKEY Clause no 1.3 – Submission of proposals of concept and preliminary designs to Employer and Funding Agency for approval – We request permission to submit the design and drawing report after the work has been awarded. 9	General – Space for temporary site setup for contractor’s office, store, yard, labor camp etc. We request you to please provide space for contractor’s site setup in vicinity of site, free of cost. We understand that the work in bidder scope shall be limit to plot boundary of each unit. We understand that the road work is not in scope of this work. Please clarify.	The Scope of Works have been fully described in the bidding document to which Bidders shall fully comply. The Scope of Works cater for both within plot boundary and outside as morefully described in the bidding document.
13	General – Secured advance – Please provide clarification regarding the secure advance. If a secure advance is not applicable, the contractor may require a payment or advance from the authority.	Advance Payment is applicable. Kindly refer to Sub clause 14.2 of the General Conditions of Contract, its respective amendments in the Particular Conditions of Contract including the Appendix to tender.

**Request for clarification/
Amendment:**

This condition could potentially reveal the secrecy/ confidentiality of the quoted price submitted by the bidders.

Also, formulation of quotation for the tenders is a conscientious procedure, and the process of fixing the final quoted price is oscillatory in nature and bidders adjust the final price till the very last moment of the bid submission.

Hence Fixing Bid Security amounting to 5% of the amount of the submitted financial offer is very contrary for the Bidders.

Therefore, we kindly request you to modify the clause and specify a fixed amount of Bid Security for each bidder.

All other Terms and Conditions of the Bidding Documents remain unchanged.
