1. Purpose of the meeting

PS Lutchia welcome all present and explained that the purpose of the meeting was for the bidders to get acquainted with the site for the proposed work.

Mr S.P. Anadachee, Lead Engineer explained briefly the nature of the work, and the health and safety considerations that should be observed while performing this project. He informed the bidders that the site should be hoarded completely and safety considerations should also be observed on the adjacent public roads during the execution of the site.

He added that the building is listed as a national heritage site in the Republic of Mauritius and consequently, the works would entail proper stacking of recoverable elements (stones and historical features) from the removal/dismantling exercise under the guidance of the National Heritage Fund (NHF). He also stated that the project would involve a comprehensive documentation exercise as per the requirements of the NHF (including sketches, photographs, etc.) which should be carried out with all necessary precautions by the Contractor in safe areas before the removal of any historical object from the site and the start of any removal/dismantling works, for record purposes. However, where there is a potential risk of partial collapse of the building, the bidders were informed to mitigate the risk by carrying out careful removal of the unstable parts prior to the documentation exercise.

Mr M.K. Mosaheb, Ag. Lead Engineer advised the bidders to read the bidding documents carefully before submitting their bids because of the complex nature of the project.

The site was visited by all present and the prospective bidders were informed that they could request for any clarifications within 14 days prior to the deadline for submission of bids as per Clause 1.1 of the Instructions to Bidders.
