However, bidders are encouraged to provide any <b>relevant organisational information</b> that will help demonstrate their capacity and suitability for the exercise and increase their chance for enlistment for the second stage, that is the RFP stage.
		Please note that more detailed documentation (e.g., full CVs, references, certifications) may be requested at the <b>RFP stage</b> for shortlisted bidders.
5.	What are the evaluation criteria and expected deliverables (course curriculum, duration, number of sessions, certification, timeline)?	Refer to paragraph (2): Scope of assignment of the TOR and S/N. 4 above.
6.	Are their any language requirements for the training course and proposal:	English language while ensuring that the information submitted is clear and understandable.
