1.0 Welcome Address

The Chairperson welcomed the prospective bidder present and gave an overview of the Bidding Document with particular attention on the qualification requirements in the Bidding Data Sheet (BDS), the main provisions in the Scope of Services and the Special Conditions of Contract. The latter also stated that the notes of the meeting will be circulated to all bidders through an addendum.

2.0 Clarifications & Amendments

The Chairperson invited the bidder to ask questions relative to the Bidding Document and the procurement process. He mentioned that:

- a) questions would be recorded with no reference as to which prospective bidder asked the questions;
- b) replies would, as far as possible, be submitted during the meeting;
- c) clarifications to the Bidding Document will be included in the addendum.

3.0 Pre bid site visits

The Chairperson informed that pre-bid site visits have been carried out as follows:

- (i) At Roche Bois and Cottage dumpsites on Monday 19 January 2026;
- (ii) At La Brasserie and La Chaumiere dumpsites on Tuesday 20 January 2026;
- (iii) At La Laura dumpsite on Wednesday 21 January 2026.

No queries/clarifications were sought from bidders during the pre bid site visits and the pre-bid meeting.
